Holly Area Schools serves to approximately 3,400 students in Northwest Oakland County. The district has four elementary schools, one middle school, an alternative education campus, and one Class A High School. The majority of the students in the district are white/caucasian. Approximately 190 staff members are certified with the vast majority having a Master's Degree or above. Approximately 50% of the student population receives free and reduced lunch.

Holly Elementary and Holly Middle School participates in the "Leader in Me" Program. Both buildings are successfully increasing student leadership and positively impacting student academic and social behaviors through the 7 Habits.

The district is reopening Sherman Middle School in the Fall of 2014. With this change, the middle school grade configuration will return to grades 6 - 8. This will also allow for continued growth of the district's early childhood programs at the four elementary buildings.

Both buildings are successfully increasing student leadership and positively impacting student academic and social behaviors through the 7

Habits. Both the Middle School and Holly Elementary hosted "Leader in Me" days this Spring for the public and other schools to attend.

Holly Area Schools is focused on growing achievement. Educators across the district are committed to improving in the following areas:

- 1. In the fall of 2015, the district will be launching the HAS Atlas Rubicon Platform as the designated warehouse for the K 12 ELA and Math Curriculum. K 12 ELA and Math Curriculum teams articulated course description, revised units of study, and determined resources to be stored in the new platform. Assessment building will be the next phase for the ELA and Math Curriculum. Science and Social Studies will enter Phase I of Curriculum Mapping in the fall of 2015.
- 2. Holly Area Schools has developed a calendar with the teachers that will introduce eight Collaboration Team dates during the school year to improve professional teaching practice through an analysis of data, progress monitoring, and overall focus on student learning. Building schedule structures have also been revised to increase the amount of grade level/content level collaboration each week.
- 3. The district is currently pursing Systems (District) Accreditation from AdvancED/NCA. Much work has already begun in preparation for this endeavor. A Readiness Review will occur in June of 2014.
- 4. The district is reopening Sherman Middle School in the Fall of 2014. With this change, the middle school grade configuration will return to grades 6 8. This will also allow for continued growth of the district's early childhood programs at the four elementary buildings.
- 5. The district is revising technology goals throughout the district and will be implementing a new K 5 technology curriculum in 2015.

We made a commitment this school year to develop a systemic, systematic, sustainable, and uniform school improvement process. A big part of this effort was participating in the Macomb FSI School Improvement Workshop Training. Each building principal along with two of their SIP Team teachers joined the Assistant Superintendent in workshops throughout the school year. The workshop dates were scheduled by MISD. All stakeholders made a commitment to be involved in this important process. As an entire group, these district SIP Leaders collaboratively set building and district school improvement goals with strategies and activities to support the goals. In addition, building and district SIP Leaders discussed school improvement efforts with school board members at meetings as well as with parents at monthly parent meetings.

Principals and SIP Team Representatives from each building joined the Assistant Superintendent in the Macomb FSI School Improvement Workshop Training. This MISD training took place throughout the year on scheduled dates. In addition, our principals and building SIP Team leaders engaged building staff in discussion and completion of school improvement diagnostics during building professional development and staff meetings. Our district K - 12 Admin Leadership Team also met monthly to discuss school improvement development across the district. Principals included input from parent groups they met with throughout the year and central office administration included input from school board members.

The district is currently engaging in a readiness review for systems accreditation. All buildings in the district are AdvancED/NCA Accredited. SIP team members across the district are excited about the pursuit of Systems (District) Accreditation from AdvancED. This process will enter Phase 2 next fall with the determination of committees to look more closely at the work that district needs to accomplish for not only meeting each of the indicators in the Standards, but also achieving a performance level of 4.

Information is posted on the district's website, presented through the district's annual education report, presented at staff meetings and school board meetings, sent home through building newsletters, and presented to civic groups. The district also works closely with local media.
